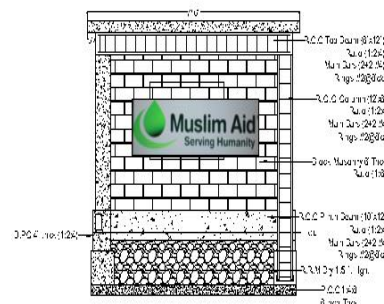
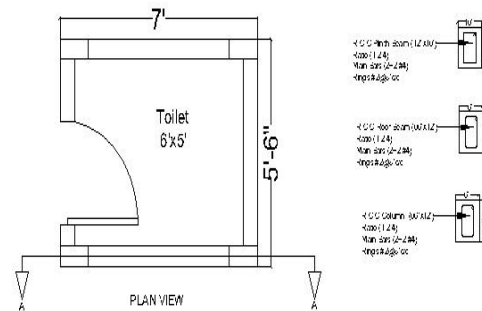




PLAN VIEW R.H.C

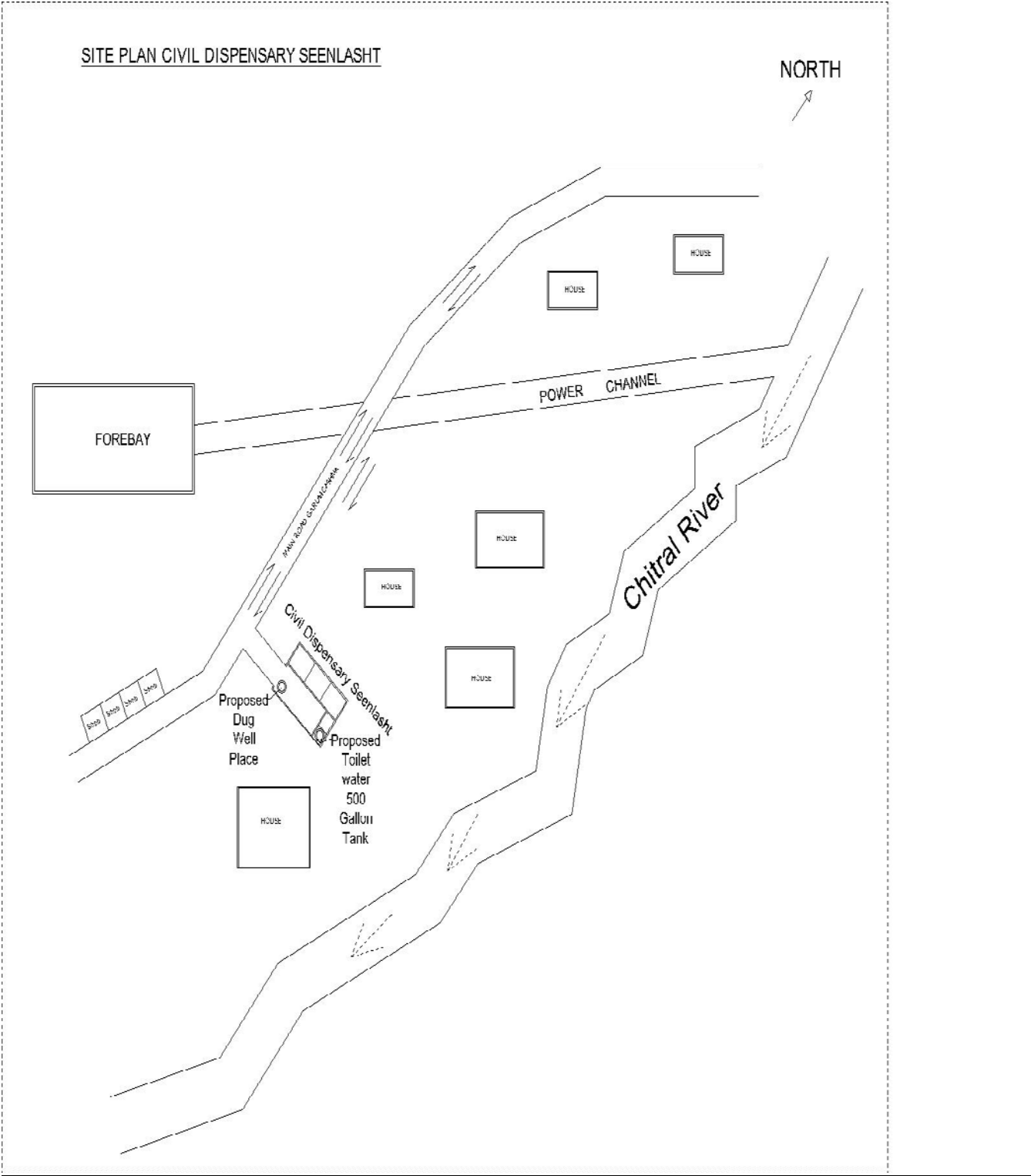

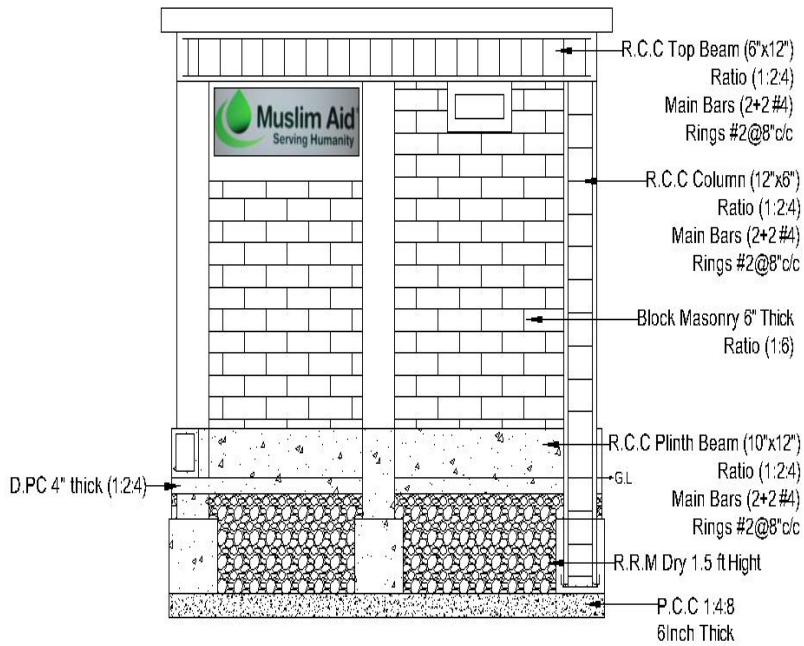
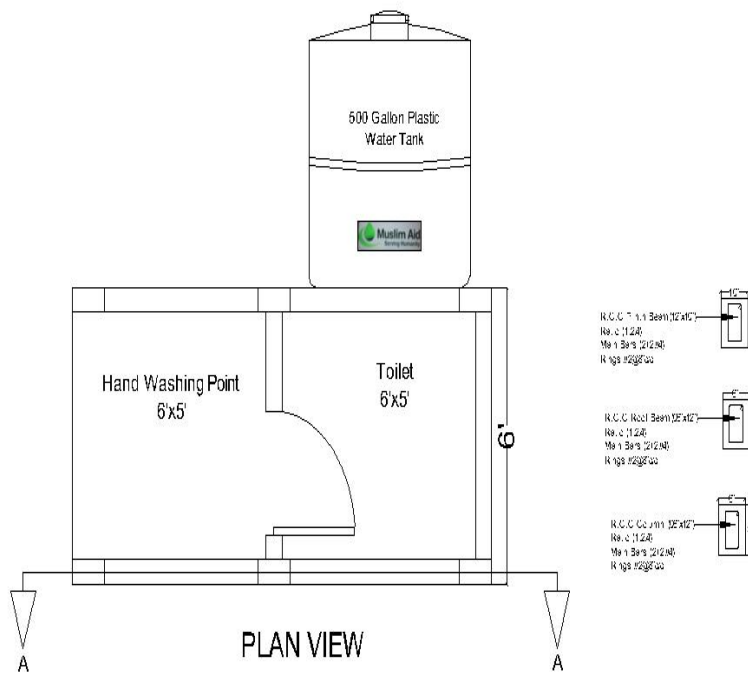
