#### 3.1. General

- Supplier shall provide CDR/DD amounting 5% (in the name of Muslim Aid) along with tender pack, CDR/DD will be returned to unsuccessful bidders after decision of tender.
- Quoted prices for the above items shall be inclusive of all kind of Govt. taxes and duties as per prevailing Tax Laws of Govt. of Pakistan, Transportation, and Custom Clearance and port taxes (if any)
- All prices must be quoted in Pak rupees.
- Supplier will keep animals in one central & separate location for pre-inspection and selection at least 5 days before Eid.
- Supplier will be responsible for animal fodder, vaccinations, and care during Quarantine period.
- Supplier will be responsible for slaughtering; skinning, cutting, packing of meat in food graded (transparent) bags with MA Logo and transportation (Cold Chain- if applicable) of packed meat to mentioned areas.
- Supplier will buy back animal Skin, Head, Feet, Liver & Heart and income from those will be deposited in Muslim Aid account.
- Supplier will be responsible for proper cleanliness and hygiene of animal keeping and slaughtering area along with proper waste disposal of animal waste after slaughtering, cutting and packing.
- Supplier will be responsible for providing weighing machines for weighing of meat pack (4 Kg).
- Any damage, loss, theft, demurrages and degradation of meat quality before delivery of meat pack at final destination will be responsibility of supplier.
- Evaluation of the quotation and award of Purchase Order shall be items wise/lot wise.
- Withholding tax & GST as per government prevailing rates shall be deducted at the time of payment.
- Payment shall be made in the form of cross cheque within 21 days after execution of order and subsequent submission of the invoice to the Muslim Aid (Pakistan).
- Muslim Aid reserves the right to reject any or all quotations without assigning any reason thereof.
- Expected delivery time must be mentioned on your quotation.
